Course Title: Incoterms 2020: what are they and why do they matter?

Course Duration: 2 Days

Course Overview:

This two-day course on the Incoterms 2020 is designed to give participants a good working knowledge of the Incoterms and how to use them in practice. The Incoterms are designed to provide a simple menu of contractual terms to small and medium businesses unfamiliar with international trade. However, they are regularly used by all sectors of the market, often together with very sophisticated GTCs. This has created some practical difficulties which this course is aimed at highlighting and preventing. For this reason the focus of the course will be to give participant a good practical understanding of how best to use the Incoterms and make the most of what they do. Participants will gain a deeper understanding of the law applicable to and surrounding the Incoterms and how it fits within the complex structure of an international trade transaction.

Learning objectives

- Be familiar with all Incoterms from EXW to DAP;
- Be conversant with the best incorporation practices;
- Understand how sale contracts may gain from the Incoterms and in which cases they do not;
- Be familiar with the structure and working of the most popular terms;

- Consolidate the ability to choose the most appropriate incoterms for the specific transaction at stake;
- Have a sound understanding of claims 'under' the Incoterms;
- Be versed with international best practices.
